The 2023 Nominating Committee consisted of Board members Winifred Pizzano (Chair), Ronald Bleeker and Kristin Dubelier, and non-Board members Jennifer Longmeyer-Wood and Mark Zetts. The committee is pleased to report out 28 nominations for the MCA Board of Directors and 5 nominations for the MCF Board of Trustees for the May 25, 2023 election ballot. The committee met a total of 6 times in-person or via Zoom. In deciding on its nominations, the Committee had taken into account experience and qualifications, and geographic distribution within MCA's defined area. This year's nominees to the MCA Board include three new persons and one returning Director.
