

The MPC did not hold a December monthly meeting.

#### MPC activities:

- At its November meeting, MPC discussed the recently filed SE application at 1566 Chain Bridge Rd. Based on the information presented and discussion, it is likely that MPC will not object to this application.
- MPC anticipates reviewing/discussing the recently issued Comp Plan language for the McLean CBC at its January monthly meeting.
- MPC will take a formal position on the proposed Comp Plan update once FxCo staff issues the final draft of the language.
- Due to the presidential inauguration and ongoing COVID-19 pandemic, MPC's January meeting will take place on <u>Thursday</u> January 21, 2021 at 7pm via Zoom (link will be posted on the MPC's website approximately one week prior to the meeting).





- MCVA Board met on December 1, 2020
- The Board is implementing the \$25K grant it received from the CARES Act to digitize its operations
